Private Swimming Pool Sewer Forgiveness Program

The purpose of this program is to offset the portion of costs associated with the cost of water used to fill swimming pools **once** in the spring. The assumption is that water from swimming pools does not enter the sewer system. Disposal of pool water is the responsibility of the home owner and subject to local jurisdiction other than the Birdsboro Municipal authority. The program offsets the sewer rate costs of water used to fill pools. Because BMA does not deliver sewage treatment to the residents of Union township, BMA is unable to extend this program to Union Township. This program is a pilot and will be reviewed for continuance on an annual basis.

Eligibility:

- Only available to residents of Birdsboro Borough. Because BMA does not deliver sewage treatment to the residents of Union township, BMA is unable to extend this program to Union Township.
- Only available to BMA customers who are registered for the program. Registration form must be accompanied by a one-time registration fee of \$25.00 made payable to Birdsboro Municipal Authority.
- **Only available to BMA customers whose accounts are current.**
- Only available for private pools located at the principal residence of the applicant
- **Program Deadline: June 30 of the current year**

Restrictions:

1. Quarterly sewer bills will be reduced by the full capacity of the pool regardless of the volume used.
2. One credit per year will be issued; additional credits will not be issued for pool refills of any amount.
3. Sewer offset may not exceed consumption for the month.
4. Misrepresentation or falsification of information will result in permanent loss of eligibility for this program.
5. This program applies to water delivered by the BMA water distribution system. Claiming water offsets for water acquired by any other means will result in permanent loss of eligibility for this program.
6. BMA reserves the sole right to determine and or revoke eligibility for this program

Pools filling must be reported by June 30 of the current year in order to participate in this program.
